Business and Legal English Programme

Outline 2014 - Oxford

Oriel College (University of Oxford, UK) and CBL International (Centre for International Business and Commercial Law) are inviting groups from selected university faculties to participate in a 4-week session of *CBL International Oxford Summer Institute at Oriel College*.

Three sessions will be held in Oxford:

- **Session 1: from 6 July to 2 August 2014**
- **Session 2: from 20 July to 17 August 2014 (very limited number of places available)**
- **Session 3: from 3 to 30 August 2014**

This exclusive programme will give participants the opportunity to attend lectures focusing on spoken as well as written business and legal English. To further improve their English language skills, participants are invited to additionally attend a large selection of lectures focusing on various relevant topics in the areas of international business law, international economics, and philosophy.

Upon completion of the course, applicants will improve their ability to comprehend and communicate with the language in both formal and colloquial forms.

CBL International Oxford Summer Institute at Oriel College is a programme with a very interdisciplinary approach. Therefore students from the following departments and schools are invited to join:

The following courses will be offered during the programme:

1. **Business and Legal English (Offered during first week only! Preparation for the level of English of all other EFL subject courses):**

- a. **Business English:** This course will focus on the reading, writing, and listening skills of the English language in a business context. By being able to understand and use the business language, participants will be able to further their career in both their work quality and building relationships among colleagues and clients.
- b. **Legal English:** This course will provide delegates the ability to communicate on an international level using precise and correct legal language. Upon completion of the course, participants will improve their confidence in explaining points of law, enhance their drafting and editing skills, and ultimately represent their organisation in a more effective manner.

For week 2, 3, and 4 you can choose to participate in one of the following courses which are all parts of the OKC EFL programmes:

- Legal Theory
 - European Business Law
 - International Taxation
 - United Kingdom Corporate & Contract Law
 - International Environmental Law
 - Global Macroeconomics
 - Financial Crisis and Policy Responses
 - Development Economics
 - Behavioural Economics
 - Historic Political and Economic Philosophy
 - Contemporary Political and Economic Philosophy
2. **Visit to London:** It is essential not only to learn the theory of international law and economics but also to understand some of the important practical aspects. Therefore included to the programme is a trip to the city of London where students will have the chance to visit some of the following: British and

Faculty

CBL International, Oriel College and all involved colleges are composing a strong team of faculty members including professors, university lecturers, university researchers, college tutors, and DPhil candidates from the University of Oxford (UK) and the University of Cambridge (UK) to teach your courses. In the meantime, we will also invite some teachers and lecturers from other prestigious universities such as London School of Economics and University of California, Berkeley, and other selected institutions.

Certificate and Academic Transcript

A certificate co-signed by Oriel College and CBL International will be issued to the participants, containing topics covered during the programme. Oxford Summer Institute is a certificate programme that may be accountable for optional credits depending on the requirements of the home institution/school/university.

The Academic Transcript will show the courses chosen and attended by each delegate. It will indicate the workload of each course as well the results of exams and assignments. Each week, one course will be taught. Combining lecture time, preparation, study time, and tests, each week is designed to be equivalent to 2 - 3 ECTS credits or 1 - 1.5 US credits.
