International Master's/Doctoral Degree Program: Information, Technology, and Society in Asia (ITASIA)

An innovative approach to understanding Asia in the information age

In 2008, the University of Tokyo launched a new International Master's/Doctoral Degree Program: Information, Technology, and Society in Asia (ITASIA) at the Graduate School of Interdisciplinary Information Studies (GSII). This program offers intensive graduate level education designed to foster analytical strength and insight into Asian societies and international relations, at a time when information and communication technology is having an increasingly profound impact on the region.

The program is tailored to both international and Japanese students who are motivated to pursue active professional careers on the regional and global stages. All instruction is given in English, so proficiency in Japanese is not a prerequisite. Unlike the conventional Japanese academic calendar, the academic year at ITASIA begins in October.

ITASIA is comprised of two degree programs: one that grants an M.A.S. (Master of Arts and Sciences) degree and the other a Ph.D. degree.

Students in the M.A.S. program are trained to grasp changing political, economic, and social realities of globalizing Asia through media, communication, and information studies together with the related methodology and skills, so that after graduation they can make appropriate judgments and recommendations in their respective professional environments. The M.A.S. program is appropriate for those interested in pursuing careers in public administration, media, business, and academic institutions.



The Ph.D. program is intended to produce high-level researchers and professionals in the fields of Asian studies and information studies. Students will acquire a broad-based knowledge of arts and sciences as well as expertise in the investigative techniques and theoretical analysis required for advanced research in politics, economics, media studies, and other social sciences.

Admissions decisions will be based on a written application that includes TOEFL and GRE scores, rather than on the customary entrance examination. In some cases the admissions committee also will conduct some kind of interview.

A certain number of scholarships will be made available based on merit.











Courses and mentoring in the ITASIA program will be supported by the faculty members of many parts of the university who have been teaching and guiding students in the Graduate School of Interdisciplinary Information Studies (GSII). Among them, faculty members of the Interfaculty Initiative in Information Studies (III) and the Institute for Advanced Studies on Asia (IASA) will make major contributions.

Shigeto SONODA is Professor of Sociology and Comparative Asian Studies. He has conducted a variety of researches energetically including *Tianjin Annual Survey* 2004-2009, *AsiaBarometer* 2003-2008, and *Japanese Companies in the Eyes of Asians* 1991-2006. He managed "Educational Program for Young Scholars on 'Asian Globalization Studies'" at GSII and a three-year project called "Frontier of Comparative Studies of Asian Societies" at IASA.

The application deadline is February 27, 2015 JST (Japan Standard Time), but those who wish to be considered for a merit-based scholarship for the program must have their application arrive by January 6, 2015 JST. Applicants must take TOEFL and GRE General Test as early as possible, because submission of their Official Score Reports in time by ETS is an indispensable part of the selection procedure.

Scholarship Opportunities

A limited number of applicants who have exceptional academic records will be awarded scholarships or tuition waivers through the courtesy of donors at the recommendation of the University of Tokyo. To those eligible, the scholarships will be offered simultaneously with the notification of acceptance into the program. The candidates will be requested to confirm their willingness to enter the ITASIA program by a specified date.

The successful applicants for admission can also directly apply for scholarships from the University of Tokyo as well as private sources, as described at http://www.utokyo.ac.jp/res03/i22_e.html, but typically only after enrollment. We strongly recommend that those applicants seeking financial support should also apply for other scholarships that can be offered before enrollment by themselves, such as Japanese government (Monbukagakusho) scholarship, the Chinese Government Graduate Student Overseas Study Program "国家建设高水 平大学公派研究生项目", etc.

Qualifications for Enrollment

To be eligible for admission to the M.A.S. program, you must be a holder of a Bachelor's degree or an equivalent

To be eligible for admission to the Ph.D. program, you must be a holder of a Master's degree or an equivalent status including Ph.D. candidateship.

Applicants who expect to earn the required degree(s) between the time of application and the end of September 2015 should submit with their application an official statement that certifies anticipated graduation.

Applicants must have at least 16 years of school education including university education or its equivalent. Applicants who have spent fewer than 16 years completing their elementary, middle, high school and university education must explain very clearly their academic history.

Please be informed that the applicants with fewer than 16 years of school education or without an appropriate academic degree may need to contact the ITASIA Admissions Office by a specified date before submitting the application. For details, please refer to Appendix 1 and 2 on ITASIA's website.

Applicants must be proficient enough in English to participate in lectures and receive academic guidance in English at the graduate level.

Students applying for the Ph.D. program should have already received extensive training that will have prepared them for pursuing advanced research. If the applicants for the Ph.D. program have received a Master's degree in a field that is not directly related to the emphasis of the ITASIA programs of to the applicants' proposed field of

study, then it is strongly encouraged that they apply instead to the M.A.S. program.

Selection for admission is based on the evaluation of documents submitted by the applicants, and, if deemed necessary, some kind of interview (including telephone, IM, etc.). It will be carried out in two phases, the first for the earlier deadline (Phase A) and the other for the final deadline (Phase B). Those who wish to be considered for the merit-based scholarships should apply for Phase A. Applicants who do not receive notice of acceptance in Phase A by February 27, 2015 will be considered again in Phase B. All the other applicants, including those for the Ph.D. program who are currently enrolled in the M.A.S. program of ITASIA, should apply for Phase B. Applicants may be contacted for additional information, with final notification no later than April 24, 2015. Successful applicants will be requested to complete the entrance procedures within a specified period.

Application Procedure

For enrollment in October 2015, the application period starts on October 1, 2014. Completed applications must be submitted to the ITASIA Admissions Office by registered mail or an international delivery service (such as UPS or FEDEX) by the date below. We strongly encourage applicants to submit materials early, since delivery may take some time. Please note that the applications that arrive after January 6, 2015 JST will not be considered in Phase A. (This earlier deadline also applies to those planning to apply for the Chinese Government Graduate Student Overseas Study Program "国家建设高水平大学公派研究生项目".) We will not accept applications that arrive after February 27, 2015 JST.

Application Documents

Please obtain the necessary forms from the Download page on ITASIA's website after mid-September 2014 and prepare the documents according to the following list. Applications must be written in English. If the other documents are not written in English or Japanese, an official English or Japanese translation should be attached unless specified otherwise.

The University may retroactively cancel admission of any student who has falsified any of his or her application documents including personal information, academic records, and research achievements.

 - An official transcript listing all courses and grades, certified with the seal/stamp of the university from which you graduated, or its registrar
 - If available, a cumulative GPA (Grade Point Average) would help the committee to assess your dossier. The GPA statement should be part of the official transcript, or, if separate, should bear an official university or registrar seal. It should include an explanation of the numerical values used to calculate the average.
 - If available, an authorized certificate of class ranking may also be included.
 - M.A.S. program applicants must submit their Bachelor's transcript, and Ph.D. program applicants must submit both their Bachelor's and Master's transcripts.
 - Applicants may request that their university send transcripts directly. If you choose to do so, please make note of that on Form #1_of your application, with the date you made the request.
- 5. TOEFL (Test of English as a Foreign Language) Official Score Report (*)(+)

 The Official Score Report must be sent by ETS
 - (Educational Testing Service) directly to the Graduate

School of Interdisciplinary Information Studies, the University of Tokyo (Institution Code: 0440). (The Examinee's Score Record is not acceptable.) Applicants must explicitly request the submission early enough taking into consideration the time required for processing and handling, and write the date of the request in Form #1. ETS will issue the Official Score Report only for a PBT or iBT taken within two years. (ITP is not accept-

- The application will not be reviewed without the arrival of the Official Score Report
- The TOEFL requirement does not apply to native speakers of English. If you identify yourself as a native speaker of English at Item 18 in Form #2, you need not submit a TOEFL score. We will review all your application from that premise. If you do not identify yourself as such, you must fulfill the TOEFL requirement.
- GRE (Graduate Record Examinations) General Test Official Score Report (*)(+)
 - The Official Score Report must be sent by ETS (Educational Testing Service) directly to the Graduate School of Interdisciplinary Information Studies, the University of Tokyo (Institution Code: 3560). (The Examinee's Score Record is not acceptable.) Applicants must explicitly request the submission early enough taking into consideration the time required for processing and handling, and write the date of the request in Form #1. ETS will issue the Official Score Report only for the tests taken within five years.
 - · GRE General Test has been revised since August 1, 2011. We accept any score either before or after the revision as long as the Official Score Report can be issued by ETS.
 - The application will not be reviewed without the arrival of the Official Score Report.

 - This sample must be submitted not only in a paper format but also as a PDF file that is burned on a CD or DVD media, unless the sample is a publication with an ISBN. The PDF file must contain accessible text data of the sample inside.
 - if the applicant has not yet graduated at the time of application, an interim thesis report is acceptable.
 - If an M.A.S. program applicant cannot submit either a thesis or a term-paper, then any other relevant
 - research paper is required.

 If the applicant has a more suitable paper related to the intended research, then it may be submitted instead.
 - If the work is not originally written in English, its summarized translation of a length of 3,000 words in English should be attached.

 - They should be written in English or Japanese.

 - The application will not be reviewed without the letters of recommendation.

Graduate School of Interdisciplinary Information Studies

The Ideal Place for the ITASIA Program

The Graduate School of Interdisciplinary Information Studies (GSII), which houses the ITASIA program, is a unique entity offering graduate level education. Graduate courses and research supervision are conducted mainly by faculty members belonging to the Interfaculty Initiative in Information Studies (III), which was created together with the GSII in April 2000. Members of many other faculties in the university also teach and guide students. In this way, the GSII is able to gather teaching staff across various disciplinary backgrounds in the arts and sciences. A system of dual advisors enables each student to engage with a "primary" and "secondary" faculty mentor, and a number of courses are open to all GSII students, no matter their program affiliation. In such an environment interdisciplinary

education in information studies can thrive. The ITASIA program, for example, is fully supported by specialists of Asian Studies posted in various faculties and research institutes within the university, including the Institute for Advanced Studies on Asia (IASA).

Besides the ITASIA program, the GSII offers four graduate programs: Socio-information and Communication Studies Course; Cultural and Human Information Studies Course; Emerging Design and Informatics Course; and Applied Computer Science Course. The academic year for these programs begins in April, and the majority of instruction is offered in Japanese.

Interfaculty Initiative in Information Studies

The Interfaculty Initiative in Information Studies (III) was founded in April 2000, together with the Graduate School of Interdisciplinary Information Studies (GSII), as a unique organization meant to carry out interdisciplinary studies of information that transcends conventional boundaries of humanities, social

sciences, natural sciences, and engineering. The Initiative gathers researchers of information from various parts of the University of Tokyo. These faculty members, bridging multiple disciplines, are full participants in the educational programs of the GSII.

The University of Tokyo (UTokyo) was established in 1877 as the first national university in Japan. As a leading research university, UTokyo offers courses in essentially all academic disciplines at both undergraduate and graduate levels and conducts research across the full spectrum of academic activity. The University aims to provide its students with a rich and varied academic environment that ensures opportunities for both intellectual development and the acquisition of professional knowledge and skills.

UTokyo has a total staff of around 10,000 and an enrollment of about 29,000, evenly divided between undergraduate and

graduate students. As of 2013 there were 2,912 international students, and 3,524 foreign researchers visited the university in 2012 for both short and extended visits. In the same year 10,435 academics visited



foreign universities for academic purposes. UTokyo is known for the excellence of its faculty and students, and ever since its foundation many of its graduates have gone on to become leaders in government, business, and the academic world.
